2012 Canton Marathon Registration Form

Waiver must be signed for registration to be processed.

Registration Fees:

No refunds or transfer of entry fees to future years for any events is permitted. There will be no race day registration. One participant per entry, including registration of children for the Father's Day event. **A \$10 administrative fee for paper entries is included in the prices listed. Paper registrations must be received by June 1, 2012.**

Event Changes:

Participants may switch races. Event changes are permitted until May 18, 2012, at 5:00 p.m. EST. Participants must notify the Canton Marathon Office of the change request by submitting a CM12 Change Request Form (form will be available online at www.CantonMarathon.com). After May 18, 2012, changes may be made at packet pick-up at the Expo, June 15-16, 2012. The administrative fee for changes is \$10 per entry along with any applicable entry fee difference.

Course Open Times and Time Limits for Participation

The full Marathon course will be open for a total of seven (7) hours. The Half Marathon course will be open for a total of four (4) hours. The 10K course will be open for a total of two (2) hours. Athletes entering the full Marathon event must maintain a 16 minute per mile pace throughout the entire race. Athletes entering the Half Marathon event must maintain an 18 minute per mile pace throughout the race. Athletes entering the 10K event must maintain a 19.5 minute per mile pace throughout the entire race. The courses will close at the respective paces listed. Anyone not able to maintain the respective paces must remove themselves from the race course and may be picked up and transported to the finish line. Any participant may be picked up at any time along the race course for not maintaining the pace time limits.

Terms of Participation / Liability and Publicity waiver

Please read waiver carefully. It includes a release of liability and waiver of legal rights and deprives you of the ability to sue certain parties. Do not agree to this document unless you have read and understood it in its entirety. By agreeing, you acknowledge that you have both read and understood the text presented to you as part of the registration process. You also understand and agree that events carry certain inherent dangers and risks which may or may not be readily foreseeable, including without limitation, personal injury, property damage or death. Your ability to participate in the event(s) is/are subject to your agreement to the waiver and by agreeing herein, you accept and agree to the terms of the waiver and release agreement.

By indicating your acceptance, you understand, agree, warrant and covenant as follows:

LIABILITY WAIVER AND RACE AGREEMENT: Read this form carefully before accepting. By signing below, you agree, warrant and covenant as follows: I know that running a road race is a potentially hazardous activity. I will not enter and run unless I am medically able to do so and properly trained. I understand the full Marathon course will be open for a total of seven (7) hours; the Half Marathon course will be open for a total of four (4) hours; the 10K course will be open for a total of two (2) hours. I understand that athletes entering the full Marathon event must maintain a 16 minute per mile pace throughout the entire race; athletes entering the Half Marathon event must maintain an 18 minute per mile pace throughout the race; athletes entering the 10K event must maintain a 19.5 minute per mile pace throughout the entire race; and that I can finish within the time frames designated for the event I am registering for and participating in. I understand that the courses will close at the pace times indicated. I understand that anyone not able to maintain the respective paces must remove themselves from the race course and may be picked up and transported to the finish line. I understand that any participant may be picked up at any time along the race course for not maintaining the pace time limits. I assume all risks associated with running in this event, including but not limited to the effects of weather, traffic, course conditions and course surfaces, falls, and contact with other runners, volunteers and spectators. I understand that events may be held over public roads and facilities open to the public during the event and upon which hazards are to be expected. I understand that the event courses are not closed courses. I understand that participation carries with it certain inherent risks that cannot be eliminated completely ranging from minor injuries to catastrophic injuries including death. I am aware that medical support for this event will be provided by volunteer personnel who may be called upon to provide assistance, including first aid, to me during or after the event. I authorize any person providing me medical care to notify and release information about my medical condition to race officials. I authorize race officials to disclose this information to anyone requesting such information. I authorize any such volunteer to assist me or to perform such assistance as in the opinion of such person may be necessary or appropriate. I understand that Canton Marathon LLC, Canton Marathon Inc., Canton Marathon, government entities within Stark County, sponsors, vendors, volunteers, and all others assisting in the operations of the event and its supporting and related activities assume no responsibility or liability with respect to my participation in the run or in any related events. I agree to obey and accept the rules of this race and any related events as published or otherwise made known to me, and to abide by the decision of any race official concerning my ability to safely complete the run. Having read this waiver and release, knowing these facts, and in consideration of the acceptance of my entry, I for myself and any person entitled to act on my behalf do hereby release Canton Marathon LLC, Canton Marathon Inc., Canton Marathon, government entities within Stark County, sponsors, vendors, volunteers, and all others assisting in the operations of the event and its supporting and related activities, together with their employees, contractors, subcontractors, directors, officers, agents, attorneys, and representatives from all claims of liabilities of any kind arising from my participation in this event or in any related activity, even though liability may arise from negligence or carelessness on the part of persons or organizations named in this waiver and release. I consent, at the race's discretion, to the release of my contact information to race partners and to the use of photographs, video, film, and sound recordings of all Marathon and related events for all legitimate purposes. Athletes who participate in this competition may be subject to drug testing by the United States Anti-Doping Agency (USADA) in accordance with the IAAF Procedural Guidelines for Doping Control or the Olympic Movement Anti-Doping Code. Any substance taken by an athlete is at his/her own risk and may result in a positive sample. Information on drugs and drug testing may be obtained by calling the USADA Drug Reference Hotline at 800-233-0393 or visiting the USADA website. I give permission to be contacted by interested media. I understand that my registration fee for the relay team includes the cost of public transportation to the relay transfer points and return to the finish line area. I understand that all entries are non-refundable and non-transferable. If I am executing this waiver on behalf of another person, I represent and warrant that such person is fully aware of the contents of this waiver, that such person has duly authorized me to execute this waiver on their behalf and that such person understands that my signing this agreement on their behalf has the same legal effect as if such person has signed it. If I am registering a child under the age of 18 or an incapacitated adult, I represent and warrant that I am the parent or legal guardian of that party and have the legal authority to enter into this agreement on their behalf and by proceeding with this event registration, I agree that the terms of this Agreement and Waiver shall apply equally to all Registered Parties. By registering a child under 13, I agree and consent to the collection of that child's information which I am providing for the purposes of registration.
